You must be clean/sober.

Your room and common areas must be clean at all times & complete assigned chores.

Maintain an atmosphere of Respect and Recovery.

No drugs or drug paraphernalia.

You must attend 90 meetings/90 days of a 12 step recovery group, unless excused.

All program meetings must be attended.

The first 30 days of residency, no travel other than meetings and works, and meeting attendance requires a chaperone.

Volunteer service during periods of unemployment: is required 3 x wk, minimum 4 hours.

All residents must be on property by 10pm during first 90 days. 11pm on Friday and Saturday. After 90 days, 12am every night.

No visitors allowed on premises.

House/Family meeting one a week, Sunday night at 9pm, attendance is required.

You are subject to random drug testing.

Employment within a pre-agreed time period is required.

No threats, or violence, or stealing.

No overnight absences from the house for the first 90 days.

Any resident vehicles must be insured and registered.
